#### **Enhancing Member Communications**


Another focus over the last year was to keep members informed about Society activities and encourage additional engagement:

strengthened. It was great to see so many members assembled in one place, and the interaction between presenters and attendees during the Scientific Program was strong. Attendees gave the conference a rating of 4.94 out of 5 in the conference evaluation form. Attendance was up, another testament to the great work done in assembling great keynotes, presenters and topics for conference attendees.

Our conference program was expanded to include information on our Poster Session, which proved to be our largest to date. During our Poster Session Reception, and indeed throughout the conference, we saw great networking among attendees, and between students and our more seasoned researchers and clinicians.

Possible future collaborations were discussed, and attendees

shared many positive comments about the quality of instruction and what they were learning. On the topic of education, please note that CE and CME credits have been sent to participants; contact out office if you have any questions.

We marketed this year's conference across numerous channels. In addition to a promotional postcard mailed to members and prospects, we created and regularly updated a new conference webpage, sent numerous emails, created a video (starring none other than our then President and President-elect). We posted updates and reminders on SCEH social media accounts (Facebook, Twitter, and LinkedIn). The event was listed on a number of conference calendars and the Hypnosis Listserv, and we reached out to fellow hypnosis societies (APA Div 30, ASCH, and ISH) and made calls and sent emails to several regional psychological societies. The annual meeting in Orlando brought many excellent workshops, an outstanding scientific program, and the opportunity to see friends and learn about cuttingedge research in clinical hypnosis.

I would like to thank Eric Willmarth for his leadership over the past year. He has worked diligently to reaffirm SCEH foundations: excellence in research and practice, solid financial stability, educational programs, and a vision for the future.

The Society is much better from his efforts and we will continue in the direction he has set in motion.

Also, I want to recognize Don Moss for his wise stewardship as Treasurer of SCEH. He has overseen our finances, identified funding for scholarships for students, and been a strong force in balancing our wishes with financial realities. To Don I am grateful.

The 2015 annual scientific meeting and workshops were a great success due to the contributions of many and our meeting Chairs. Attendance was up this year and the programs were outstanding. Dr. Michael Nash served as the overall program Chair and did a superb job in bringing about the best presenters. Devin Terhune and Shelagh Freedman organized an outstanding scientific program that brought "cutting edge" research into biogenetics and hypnosis, hypnotizability, mindfulness, dissociation, and a range of topics related to clinical applications. The workshop Chairs: Basic -David Godot and Scott Hove: Intermediate - Marcia Greenleaf and Laurie Lipman; and Advanced Co-Chairs - Philip Shenefelt and Claire Frederick organized an outstanding program with some of the most skilled teachers/clinicians in the field

Our International Journal of Clinical and Experimental Hypnosis continues to be the leading journal in the field under the Editorship of Dr. Arreed Barabasz. I also want to note that the IJCEH and American Journal of Clinical Hypnosis are both

available on our website as a member benefit.

In regard to finances, please be sure to pay your annual dues in a timely manner. SCEH depends upon dues as a primary source to sustain our programs and I would ask that you please respond to your dues statement as soon as you receive (or have received) it. We need your commitment to SCEH to achieve our mission of excellence and progress in hypnosis research, education, and clinical practice.

I also want to thank the Executive Council for their governance role in SCEH and support of our growth. In looking toward the coming year there are several objectives that we will pursue in the next several months leading up to the 2016 annual meeting in Boston next year. To a very large degree these objectives emerged from the *Strategic Planning* initiated by Eric Willmarth during the last year. I will summarize some of the primary objectives and progress. The Strategic Planning Committee identified four primary objectives.

#### **Clarify Member Requirements** and Make it Easier to Join **SCEH**

Membership in SCEH is restricted to qualified individuals who have an interest in hypnosis research and clinical practice. The Strategic Planning Committee identified a need to clarify/simplify requirements, speed up approval and make it a less cumbersome process for qualified individuals to become a member. We have already made some excellent progress in this direction. As Chair of the Strategic Planning Committee it was apparent to me that this was a clear priority and Dr. Zoltan Kekecs has revised the membership application consistent with these goals. The revised membership application has now

been approved by the Executive Council and is available in paper form and it will soon be possible to complete it online on the SCEH website. WE NEED MEMBERSHIP GROWTH, please support these efforts by (1) downloading a copy of the revised membership application and (2) recruiting at least one new member to SCEH. Many of you teach workshops, classes, or provide clinical training and I would ask that you please encourage membership in our wonderful organization - SCEH.

#### **Improve ACE Certification**

Dr. Roger Carlson is the Chair of the SCEH Certification Committee. The Strategic Planning Committee identified a second objective – to strengthen criteria/requirements, then increase marketing efforts of the SCEH Certification in Clinical Hypnosis. This will involve bringing the currently certified member list up-to-date, sending out certificates of SCEH Certification, and then consideration of revision of

#### **Expand Participation in Educational Offerings**

During the next year we plan to review opportunities for a midyear meeting and online learning programs, and at the same time, attract more new faces, as well as current members, to the Annual Conference. Additionally, we will explore the opportunity of a midyear meeting or workshop in addition to the annual meeting. This can be a source of increased revenue, as well as providing more training in evidence-based practice of hypnosis among clinicians.

In looking toward the 2016 Annual Scientific Meeting and Workshops in Boston, there are several people that I would like to recognize. The overall Chair of the 2016 meeting in Boston is Dr. Nicholas Covino. The Advanced Workshop CoChairs will be Werner Absenger, PhD and Daniel Handel, MD. The Intermediate Workshop will be Co-Chaired by Scott Hoye, PsyD, and Ian Wickramasekera, PsyD, the Introductory Workshop in Clinical Hypnosis will be Co-Chaired by David Godot, PsyD and Eric Willmarth, PhD. The Scientific Program will be Co-Chaired by Devin Terhune, PhD and Zoltan Kekecs, PhD. More information will be forthcoming soon. Please plan to attend and present your clinical skills and research. We plan to have "panel of experts" sessions, current research, practical sessions on billing for hypnosis services, and thoughts on ways to adapt clinical practice to the changing health care environment. The theme of the 2016 annual meeting will be: The Future of Clinical and Experimental Hypnosis in the Era of Health Care Reform. The program will be both clinically geared and focused on how clinicians and researches can best be prepared for possible changes in the health care landscape in the era of change.



## IN MEMORIAM Claire Frederick, MD 1932-2015

The sudden loss of our esteemed colleague, Dr. Claire Frederick, has been a profound one for the worldwide hypnosis community as well as for SCEH. Her contributions have been copious and pervasively influential. Remarkably, she was as accomplished as a teacher and as an author as she was as a clinician. raised, an only child, in New Her wide range of intellectual interests and contributions extended beyond her expertise in clinical and medical hypnosis to include the domains of philosophy, Louisiana State University ego-strengthening, developmental repair, trauma and dissociation,

mind-body problems, obsessivecompulsive disorder, and issues with loss, grief, and death and dying. As a clinician, she was often the therapist of last resort for patients who had long since lost hope of recovery.

Claire was born in 1932 and Orleans, Louisiana. After attending period of years in the 1970s. Sophie Newcomb College and graduating Phi Beta Kappa at the age of 19, she earned her MD at Medical School in 1955. She completed her residency in

Neurology and Psychiatry at University of Virginia Hospital in 1958, and then pursued a clinical fellowship at the National Institute of Mental Health. She subsequently received board certification from the American Board of Psychiatry and Neurology in 1963. She was married to Arthur Frederick for a

Claire took her first hypnosis training workshop with William Kroger in 1978 and then sought out an eclectic foundation of training experiences. After

studying with Jack and Helen Watkins, she became committed to developing the theory, methods, and applications of Ego State Therapy. A prolific author in the literature on hypnosis, her publications include twenty five articles and two classic coauthored books, Healing the Divided Self: Clinical and Ericksonian Hypnotherapy for Post-Traumatic and Dissociative Conditions (with Maggie Phillips, 1995) and Inner Strengths: Contemporary Psychotherapy and Hypnosis for Ego-Strengthening (with Shirley McNeal, 1999). Her definitive monograph on Ego State Hypnosis. The Milton Erickson Therapy, "Selected topics in ego state therapy," was published by the International Journal of Clinical and Experimental Hypnosis in 2005. She was also a past Editor of the American Journal of Clinical Hypnosis as well as an Editorial Consultant to the International Journal of Clinical and Experimental Hypnosis.

Her numerous academic appointments included teaching appointments at the Medical College of Virginia, Tufts University School of Medicine, and Harvard Medical School. Most recently, she served as **Distinguished Consulting Faculty** at Saybrook University in the College of Humanistic and Clinical Psychology.

As testimony to her contributions, Claire received several prestigious awards. Among them were the American Society of Clinical Hypnosis and the Society of Clinical and Experimental

Hypnosis Presidential Awards; an ASCH Award of Merit as an outstanding clinician, teacher, and author, and the Crasilneck Award for excellence in writing. She also received the Cornelia Wilbur Award for original contributions to the field of dissociation. In 2005, SCEH gave her the Annual Schneck Award to the physician who has made significant contributions to the development of medical hypnosis, and, in 2007, the Roy M. Dorcus Award for the Best Clinical Paper published in the International Journal of Clinical and Experimental Institute in South Africa also honored her for her "contributions to psychotherapy and to hypnosis." Most recently, in August 2015, she had been invited to Paris to receive the first Helen and Jack Watkins award from the International Society for Hypnosis.

Claire was a generous and tireless contributor to the Societies to which she belonged. She organized scientific and workshop programs as Chair and was a sought after member of Executive Boards and Education committees. Over the years, she made generous teaching contributions to generations of beginning and advanced students in her unique workshops that invariably drew rave reviews. She was elected a Fellow of SCEH, of ASCH, and of the International Society for the Study of Trauma and Dissociation. She also received honorary memberships in the British Society for Medical and Dental Hypnosis, the Canadian Federation of Clinical Hypnosis, Alberta

Division, and the Canadian Society of Clinical Hypnosis, Ontario Division.

But beyond all of the remarkable accolades and achievements, however, perhaps Claire's most impressive accomplishments were her connections with other peopleas evidenced by the outpouring of grief at her passing from those colleagues, friends, students, and patients who had the great good fortune to know her. The vast majority of them would declare that Claire had somehow touched them, deeply, in enduring and uniquely transformative ways. Despite her ribald sense of humor, hearty laugh, and inclination toward pranking those around her, she proffered profound respect to people – from the beginning students, like those she met for the first time at her very last workshop at SCEH in Orlando in September, 2015, to those colleagues she consistently encouraged, over the years, to stretch themselves personally and professionally in ways they had never imagined. Although Claire did not have close blood relatives, she had myriad friends that she had made across the globe who, despite not seeing her frequently, somehow felt that they were next of kin. She was probably the only senior clinician who, when she posted to the Hypnosis List Serv, would sign her posts "love, Claire". So many of us reciprocate that sentiment and feel inestimably grateful to have had her in our lives for as long as we did. Yet, despite that, we feel sure that we have lost her all too soon.

## **Obituary Claire Frederick**

Published in The Boston Globe on Oct. 18, 2015

Dr. Claire (Cobb) Frederick, 83, passed away unexpectedly on October 6, 2015. A proud native of New Orleans, she subsequently practiced in California, Massachusetts, and Maine as a psychiatrist who specialized in psychotherapy and medical hypnosis.

An inspiring teacher and author as well, she was internationally known for her seminal contributions to the field of clinical hypnosis through her books, articles, and myriad, award-winning professional contributions to the professional societies of which she was a revered member.

Previously on the faculties of Tufts University Medical School, and Harvard Medical School, she was most recently Consulting Faculty at Saybrook University in San Francisco. A past editor of the American Journal of Clinical Hypnosis, and coauthor of two classic books on hypnotherapy and dissociative disorders, she taught nationally and internationally.

An avid reader, and a lifetime learner as well as a teacher, she also loved cooking and eating gourmet food, hiking, films, the latest tech gadgets, and the companionship of animals and her circle of beloved friends.

She is mourned by her wide community of patients, students, colleagues and loving friends, who she graced with her knowledge, wit, and magnanimous spirit. Memorial donations may be made, in her name, to a charity fostering environmental and animal welfare such as Defenders of Wildlife.

Yes, Claire was warm, kind, generous, supportive, and nurturing. But let's not forget that she was a major contributor to our field, had a razor-sharp intellect, an incredible sense of humor, an intolerance of nonsense (usually expressed with a jest rather than in open anger), and a willingness to stand on principle even in difficult situations. Claire's humor was not restricted to the usual range of jokes, witty remarks, wonderful stories, and zingers...

She retained a love for old-fashioned slapstick, which she indulged until physical limitations got in the way of her more physical humor.

It would be a disservice to Claire's memory to overlook her marvelous skill with pranks, often in the context of ASCH Regional Workshops.

Let's remember her warm and loving heart, her remarkable mind, her sharp wit, and her prowess in tossing a rubber chicken into otherwise proper and mannerly occasions.
